## **Mental Health**

The Christian Brothers Employee Benefit (EBT) and Religious Medical Trusts (RMT) offer 24/7 access to physicians, 365 days a year through Teladoc for all members who are enrolled with medical coverage.

This telemedicine benefit offers accessible and convenient care, as well as providing patients and physicians a way to communicate, which bypasses the traditional office visit yet provides excellent care through the use of technology.

## **Mental Health**

Teladoc allows you confidential access to mental health professionals in the setting of your choice. You choose from board-certified psychiatrists, licensed psychologists, therapists or counselors.

- Talk to the same therapist on-going, if you choose, for anxiety, eating disorders, depression, grief, family difficulties, and more.
- Available seven days a week, from 7 a.m. to 9 p.m. local time, by phone or video.
- Receive discreet and confidential support from wherever you are most comfortable.

## Why members reach out:

- If you want to establish a relationship with a licensed therapist or psychologist.
- If you're experiencing new or worsening anxiety or depression.
- If you need help managing PTSD or other trauma.
- If you need help with marital or relationship issues.
- · If distance makes an office visit difficult.
- · If your current therapist is unavailable.

## How it works:

- Log into your account at <u>mycbservices.org/health</u> and click "My Teladoc" or register via <u>Teladoc.com/</u> 800.835.2362.
- 2) Provide basic information through web, mobile, or phone and complete medical history similar to the paperwork requirements at a doctor's office.
- Choose a care provider by reviewing provider profiles, including specialty, language, gender, and ability to prescribe medication.
- 4) Select three dates and times for the initial visit. Providers respond within eight hours, and are confirmed within 72 hours.
- 5) Provider meets with you via video and provides treatment and goal setting.
- 6) Schedule future appointments with the same provider and follow-up through the secure online message center.

Due to the Internal Revenue Service (IRS) requirements of Health Savings Account (HSA) plans, in order to preserve the pre-tax status of the HSA, members must be charged a fair market value for Teladoc services. The fair market value for General Medical visits is \$65 for 2025/2026; Dermatology visits, \$85; Nutrition Consultation, \$59; Therapist visits, \$90; \$220 for Initial Psychiatrist Evaluations and \$100 for Ongoing Sessions; Primary360 Services, \$165 per New Participant, \$99 per Primary Care Consultation, and no charge for Annual Wellness Check up.
