Nutrition

The Christian Brothers Employee Benefit (EBT) and Religious Medical Trusts (RMT) offer 24/7 access to physicians, 365 days a year through Teladoc for all members who are enrolled with medical coverage.

This telemedicine benefit offers accessible and convenient care, as well as providing patients and physicians a way to communicate, which bypasses the traditional office visit yet provides excellent care through the use of technology.

Nutrition

Teladoc offers the Nutrition program to help you stay healthy or manage a condition. Nutrition offers access to registered dietitians who assess clinical nutrition needs and develop personalized programs for each member—all based on the latest, science-based guidelines for clinical nutrition. Trained in counseling techniques based on the ideas of partnership, non-judgment and compassion, Teladoc dietitians can help with health conditions like:

- Diabetes
- High blood pressure
- High cholesterol
- Weight loss
- Food allergies
- Digestive issues
- Preconception and pregnancy
- Menopause
- And more ...

How it works:

- 1) Set Up your Account in one of three ways:
 - Call **800.835.2362** or
 - Download the Teladoc app on Apple App Store or Google Play or
 - Log into your account at mycbservices.org/health and click "My Teladoc."
- 2) Complete medical history similar to the paperwork requirements at a doctor's office.
- 3) Select a registered dietitian and an available date and time for an appointment.
- 4) Talk to a registered dietitian by phone or video seven days a week (7 a.m. to 9 p.m. local time, based on availability).
- 5) Complete a nutrition assessment so you can receive your personalized nutritional plan other materials at the end of your visit.

Due to the Internal Revenue Service (IRS) requirements of Health Savings Account (HSA) plans, in order to preserve the pre-tax status of the HSA, members must be charged a fair market value for Teladoc services. The fair market value for General Medical visits is \$65 for 2025/2026; Dermatology visits, \$85; Nutrition Consultation, \$59; Therapist visits, \$90; \$220 for Initial Psychiatrist Evaluations and \$100 for Ongoing Sessions; Primary360 Services, \$165 per New Participant, \$99 per Primary Care Consultation, and no charge for Annual Wellness Check up. Subject to change without advance notice.
